## STREETS/ROADS: (COUNCILMAN SANTAGATA)

Council President reported that all borough lights have been removed from the Mazzoni property. In addition, Atlantic City Electric has been contacted to disconnect the electric. Remington and Vernick Engineers are checking on chemicals being stored in the building.

Road Supervisor Nimohay attended the FEMA meeting with Emergency Management Coordinator Gazzara to obtain funding for the December 2010 snow storm.

Remington and Vernick Engineers are preparing Storm Water Management material for the NJ DEP.

### RECREATION: (COUNCILMAN ZAPPARIELLO)

Councilman Zappariello reported that the next meeting of the Recreation Commission will be held on March  $2^{\rm nd}$ . The Easter Egg Hunt will be held on April  $16^{\rm th}$  or  $23^{\rm rd}$ . Councilman Zappariello will be assessing the damage in the park in an effort to have everything in order for the coming season.

Opening Day for baseball/softball will be April  $9^{\rm th}$ . Try outs were held on February  $26^{\rm th}$  at the middle school. Councilman Zappariello stated that he is impressed with the leadership of the association.

Councilman Zappariello reported that a walking club was formed and they will be using our facilities. In addition, the Councilman was approached to discuss the possibility of using the park for Hula Hoop classes. Solicitor DeSanto stated that the Borough would have to allow the use under the equal access statute provided the organization meets the requirements set forth in our code.

Notre Dame Regional School will be hosting a 70/80s Dance on March  $4^{th}$ .
