**The regular meeting of Mayor and Council of the Borough of Buena was held August 12, 2024 commencing at 7:00 P.M. at the Borough Hall with Mayor Baruffi presiding. Mayor Baruffi announced that this meeting was being held in compliance with the Open Public Meetings Act and notices of this meeting have been provided, via email, to the Press of Atlantic City and the Daily Journal on November 27, 2023 as well as being posted on the bulletin board in Borough Hall.**

**MAYOR’S REPORT: First order of business.**

- Third quarter tax bills with the mayor’s first newsletter of the year were prepared on Friday, August 2 and Monday, August 5 and were mailed Tuesday, August 6 in a cooperative spirit by Joyce of the tax collector’s office, Nicole in the clerk’s office, Administrator Coraluzzo, Councilwoman Pat Andaloro, and myself. Mayor Baruffi thanked everyone for a job well done.
- Provided a status report for Route 40, Central Ave, and Kimberly Lane project noting receiving an email from John Saban, Chief of Staff-4<sup>th</sup> Legislative District which states the Concept Development phase anticipates completion in the summer of 2025 due to required extensive drain analysis. The Department anticipates construction to begin in late 2027 due to impacts to ROW/utility/permits during final design.
- Sent follow-up letters last week to County Administrator DelRosso regarding current status to the contract for the Louise Basile Center. A meeting had been requested with Administrator DelRosso to discuss questions regarding the contract.
- Sent a follow-up letter to Chief County Engineer DeMio regarding drainage issues at Summer and Brewster requesting a meeting to expedite the process.
- Attended a meeting on August 1 in Vineland at the South Jersey Transportation Planning Organization for information regarding traffic safety. There are programs available to all ages that the organization is willing to make available to Borough residents at little to no cost. Mayor and Council President Adams will meet with the organization to obtain more information regarding the programs.
- Signatures are complete for demolition for 1005 S Central Avenue.
- Community Gardens has access to water.
- The old metal building on South Blvd is in the process to be cleaned up and demolished. The interior will be cleaned first and the Borough will obtain a quote for asbestos removal.
- Atlantic County will cut bushes on the corner at the intersection of Brewster and Weymouth Road to clear the site triangle for drivers.

**THE BOROUGH COUNCIL OF THE BOROUGH OF BUENA, IN THE COUNTY OF ATLANTIC, NEW JERSEY** (not less than two-thirds of the full membership thereof affirmatively concurring), **DOES HEREBY ORDAIN AS FOLLOWS:**

**SECTION 1.**

The improvements described in Section 2 of this ordinance are hereby authorized to be undertaken by the Borough of Buena, County of Atlantic, State of New Jersey (the “**Borough**”), as general capital improvements. For the improvements or purposes described in Section 2, there is hereby appropriated the sum of \$52,000 as required by the Local Bond Law. The total sum is now available by virtue of funds available within the Reserve for Fire Department Expenditures Fund.

**SECTION 2.**

The Borough hereby authorizes the appropriation of \$52,000 from the Reserve for Fire Department Expenditures Fund for the purchase of equipment for the Fire Department and for the construction of improvements to the Fire Department Building (including all related costs and expenditures incidental thereto).

**SECTION 3.**

The improvements described in Section 2 of this ordinance are not current expenses. They are all improvements or purposes that the Borough may lawfully undertake as general improvements having a period of usefulness of at least five (5) years, and no part of the cost thereof has been or shall be specially assessed on property specially benefited thereby.

**SECTION 4.**

Any grant moneys received for the purposes described in Section 2 hereof shall be applied to the direct payment of the cost of the improvements.

**SECTION 5.**

The Borough hereby certifies that it has adopted a capital budget or a temporary capital budget, as applicable. The capital or temporary capital budget of the Borough is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency herewith. To the extent that the purposes authorized herein are inconsistent with the adopted capital or temporary capital budget, a revised capital or temporary capital budget will be filed with the Division of Local Government Services.

**SECTION 6.**

This ordinance shall take effect immediately upon final adoption and publication as required by law.

**WHEREAS**, the Council of the Borough of Buena has determined that in order to assure and to provide for the health, safety and welfare of the residents of the Borough of Buena it is necessary to establish a licensing procedure for businesses operating tow vehicles that may be towed by law enforcement for the quick removal and storage of abandoned, illegal and/or inoperable vehicles on public and private property in the Borough of Buena; and

**WHEREAS**, on June 13, 2022, the Council of the Borough of Buena adopted Ordinance 709, Chapter 223 of the Code of the Borough of Buena, setting forth the process for owners and operators of such facilities to be so licensed, however, as a result of the police services now being provided by the Township of Franklin, Gloucester County (Franklin), it is necessary to amend Chapter 223, Section 223-14 to reflect the operation of police services by Franklin and to adopt a uniform fee schedule to coincide with that of Franklin Township.

**NOW, THEREFORE, BE IT ORDAINED** by the Council of the Borough of Buena that Chapter 223, Section 223-14 entitled **Rates and fees for service** of the Code of the Borough of Buena be amended as

follows:

Section 223- 14 entitled **Rates and fees for service** shall be deleted in its entirety and replaced as follows:

**Section 223-14 Rates and fees for service**

- A. When performing services under the Police Tow List to tow and/or store a motor vehicle, the towing charge and storage charge shall not exceed those charges as set forth in this chapter. These are maximum fees that may be charged.
- B. The fee schedule effective at the time of adoption of this chapter is as follows:
  - (1) Towing.
    - (a) Days:
      - [1] First mile or less: regular duty, \$150; heavy duty, \$450 (per hour) (payable in fifteen-minute increments).
      - [2] Each additional mile: \$5.
    - (b) Nights, weekends and New Jersey state holidays:
      - [1] First mile or less: regular duty, \$175; heavy duty, \$450 (per hour).
      - [2] Each additional mile: \$5.
  - (2) Storage - will be billed per calendar day.
    - (a) Inside building.
      - [1] Per vehicle/per day: regular; \$60/heavy duty; \$125/oversized; \$200.
    - (b) Outside secured.
      - [1] Per vehicle/per day: regular; \$45/heavy duty; \$100/oversized; \$150.
  - (3) Additional fees.
    - (a) Cleanup: \$50 (per hour).
    - (b) Oil dry: \$25 (per bag).
    - (c) Administrative fee: \$50.
    - (d) Winching fee: basic, day: \$100; night: \$150;
    - (e) Vehicle rollover: day: \$150; night: \$200.
    - (f) Heavy-duty laborer: \$90 (per man per hour).
    - (g) Heavy-duty support vehicle: \$160 (per hour).
- C. The fees set forth on the schedules for towing rates are the maximum charges that shall apply to a motor vehicle for basic towing services. Fees related to other than basic towing services will be calculated on an incident by incident basis and at a standard estimated prevailing rate.
- D. The towing rates shall be calculated based on the total distance traveled from the tow vehicle's base of service to the job site and return by way of the shortest available route. Fractions shall be rounded up to the nearest whole mile.
- E. Tow vehicles transporting multiple motor vehicles at one time may charge the applicable fee for each

such vehicle transported.

- F. When towing services are otherwise required, the day rate shall apply when the vehicle is transported (pickup and delivery) entirely between the hours of 8:00 a.m. and 6:00 p.m., Monday through Friday, except New Jersey state holidays. The night, weekend and holiday rate shall otherwise apply.
- G. The Chief of Police shall post fees, available to the public, during normal business hours along with a copy of this chapter and the fee schedules of licensed towing operators.
- H. Payment from the public shall include credit cards.

**BE IT FURTHER ORDAINED** that the balance of Ordinance 709 not amended hereby shall remain in full force and effect.

**BE IT FURTHER ORDAINED** that any Ordinance or portion thereof that is inconsistent with the terms of this Ordinance shall be repealed to the extent of such inconsistency.

**BE IT FURTHER ORDAINED** that should any portion of this Ordinance be deemed void by a Court of competent jurisdiction, the balance hereof shall remain in full force and affect.

**WHEREAS**, Borough Council passed a motion to refer a question to the Buena Borough Land Use Board (BBLUB) to consider an amendment to the Buena Borough Municipal Land Use Laws (MLUL) to consider an amendment to so as to set forth restrictions upon the right to keep and maintain chickens, turkeys ducks and other fowl and poultry in certain residential zones and to provide findings of fact and recommendations thereto; and

**WHEREAS**; on July 23, 2024 the BBLUB considered the motion and passed a Resolution recommending certain changes to Chapter 15, Article XVI, Section 150-36 recommending an amendment to the Buena Borough MLUL and the Governing Body adopts the findings of fact and recommendations set forth in said BBMUB Resolution as if set forth herein at length.

**NOW, THEREFORE, BE IT ORDAINED** by the Council of the Borough of Buena that Ordinance 395, as amended, Chapter 150 Article XVI, Section 150-136 entitled Farming rights; restrictions and permitted nuisances shall be amended as follows:

Section 150-136 A, B, C, and D shall be deleted in their entirety and replaced as follows:

§ 150-136 Farming rights; restrictions and permitted nuisances.

- A. The right to farm shall be protected in the A-1, R-4 and R-5 Zones, as well as the P-A and P-R4 Zones of the Pinelands Area, subject to the regulations governing farm and

livestock operations, to the prohibited uses specified below, to the standards set forth in the schedules herein[1] and to the health and sanitary codes.

- B. The right to farm protection includes the right to use irrigation, fertilizer, insecticides and herbicides, as well as the right to house and graze farm animals.
- C. The right to farm protection shall not extend into the R-1, R-2 and R-3 Zones and the P-R3 Zone of the Pinelands Area, nor shall it extend into the B-1, B-2 and B-3 Zones and the P-B2 Zone of the Pinelands Area, nor shall it extend into the I-1 Zone and the P-I Zone of the Pinelands Area.
- D. In all zones except the A-1 as well as the P-A and P-R4 Zones of the Pinelands Area, the keeping of farm animals such as horses, cows, bulls, mules, donkeys, poultry, rabbits, sheep or goats shall be prohibited unless the property on which they exist comprises at least three acres and said farm animals are not bred for commercial purposes.
  - (1) No more than five farm animals or 25 rabbits, chickens or other poultry may be kept on such three-acre properties, except for in the R-4 and R-5 Zones, where no more than five farm animals or 10 rabbits, chickens or other poultry may be kept on such three-acre properties.
  - (2) All structures required to shelter animals on such three-acre properties shall be limited to no more than 50% of the square footage of the dwelling existing thereon.
  - (3) All farm animals kept on such three-acre properties shall be properly fenced and contained to prevent them from wandering onto neighboring lands or public streets.
  - (4) The housing and grazing of said animals on such three-acre properties is prohibited unless the owner or keeper resides in a dwelling house on the same lot or on a contiguous lot to that on which the animals are housed and grazed

**BE IT FURTHER ORDAINED** that any Ordinance or portion thereof that is inconsistent with the terms of this Ordinance shall be repealed to the extent of such inconsistency.

**BE IT FURTHER ORDAINED** that should any portion of this Ordinance be deemed void by a Court of competent jurisdiction, the balance hereof shall remain in full force and affect.

**WHEREAS**, the BBMUA is an entity that was established by Ordinance and the members of the authority are appointed by the Council of the Borough of Buena; and

**WHEREAS**, the Borough Council of the Borough of Buena pursuant to N.J.S.A. 40A:60-6, et seq, has the authority to undertake special investigations regarding any agency that falls within their legislative purview; and

**WHEREAS**, there have been these recent issues that have brought into question the business, billing, administrative and customer service practices of the BBMUA that require a special independent investigation be conducted in order to assist the governing body in this legislative process.

**WHEREAS**, the Borough Council shall convene a subcommittee of council of the entire council to meet with the representatives of the BBMUA and discuss their issues and concerns prior to moving forward with any further investigation, if necessary.

**NOW, THEREFORE, BE IT RESOLVED** by the Borough Council of the Borough of Buena that a committee of council shall meet with the representatives of the BBMUA prior to commencing of any formal investigation or inquiry to address all concerns and if necessary, shall authorize an independent investigation of the BBMUA's business, billing, administrative and customer service practices.

**WHEREAS**, an emergency has arisen with respect to the budget line for “Fire Protection” due to the fact that certain start up expenses related to the assumption of the responsibility for management of “Fire Protection Services” by the Borough of Buena, were greater than originally anticipated, and it is in the best interest of the Borough to protect and promote the public health, safety and welfare of the Borough; and

**WHEREAS**, no adequate provision was made in the 2024 budget for the aforesaid purposes, and the N.J.S.A. 40A;4-46 provides for the creation of an emergency appropriation for the purpose above mentioned; and

**WHEREAS**, the total amount of emergency appropriation created including this appropriation to be created by this resolution is \$40,000.00 and three percent of the total operations in the budget for the year 2024 is \$162,665.00,

**WHEREAS**, the foregoing appropriation together with prior appropriations does not exceed three (3) percent of the total operating appropriations in the budget for 2024,
