BE IT RESOLVED BY THE BOROUGH COUNCIL OF THE BOROUGH OF BUENA, IN THE COUNTY OF ATLANTIC, NEW JERSEY (not less than the majority of the full membership of the governing body) AS FOLLOWS:

- Section 1. In anticipation of the collection of taxes during the current fiscal year, there are hereby authorized to be issued tax anticipation notes of the Borough, each to be known as "Tax Anticipation Note of 2020," in amounts not exceeding \$3,000,000.00. The proceeds of such notes shall be applied only to purposes provided for in the budget or for which taxes are levied for the current year.
- Section 2. The following certificate has been prepared by the Chief Financial Officer and is filed in the office of the Borough Clerk:

# CERTIFICATE WITH RESPECT TO TAX ANTICIPATION NOTES

- I, Cindi Holland, Chief Financial Officer of the Borough of Buena, in the County of Atlantic, New Jersey HEREBY CERTIFY as follows:
- 1. The gross borrowing power in respect to tax anticipation notes for the fiscal year of 2020, being 30% of the tax levy for all purposes of the fiscal year of 2019, plus 30% of the amount of miscellaneous revenues realized in cash during the fiscal year of 2019, is \$3,130,818.00.

- 2. The amount of notes outstanding in anticipation of the collection of taxes of the fiscal year of 2020, except such notes as will be renewed by or paid from the proceeds of the notes to be issued, is \$0.

- 4. This certificate is made with respect to \$3,000,000 Tax Anticipation Notes of 2020 about to be authorized by the Borough Council of the Borough of Buena.
