**ORDINANCE NO. 634 NEED MOTION TO OPEN THE PUBLIC HEARING ON:**

**ORDINANCE REAPPROPRIATING \$54,543.61 PROCEEDS OF OBLIGATIONS NOT NEEDED FOR THEIR ORIGINAL PURPOSES IN ORDER TO PROVIDE FOR OTHER PURPOSES IN AND BY THE BOROUGH OF BUENA. m/Baker s/Cugini**

BE IT ORDAINED BY THE BOROUGH COUNCIL OF THE BOROUGH OF BUENA (not less than two-thirds of all members thereof affirmatively concurring) AS FOLLOWS:

Section 1. Pursuant to N.J.S.A. 40A:2-39, it is hereby determined that \$31,636.35 of the proceeds of obligations originally made available pursuant to Bond Ordinance No. 597 of the Borough of Buena, a municipal corporation of the State of New Jersey (the "Borough") finally adopted on October 9, 2012, as amended by Bond Ordinance No. 606 of the Borough finally adopted on February 25, 2013; and \$22,907.26 of the proceeds of obligations originally made available pursuant to Bond Ordinance No. 610 of the Borough finally adopted on June 24, 2013, are no longer necessary for the their original purposes. The \$54,543.61 aggregate proceeds are hereby reappropriated as follows: \$54,543.61 to provide for various road and drainage improvements to various streets throughout the Borough (including, but not limited to, Plymouth Road, Louis Drive and Forest Grove Road), including all work and materials necessary therefor or incidental thereto.

Section 2. The capital budget of the Borough is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency herewith.

Section 3. This ordinance shall take effect 10 days after the first publication thereof after final adoption.

WHEREAS, the Open Public Meetings Act of 1975 requires that a schedule of regular meetings of the Council of the Borough of Buena be annually posted and maintained in one public place reserved for public announcements, and requires that the annual notice be filed and maintained by the Clerk of the Borough of Buena; and

WHEREAS, Section III of the Open Public Meetings Act of 1975 requires certain notices of meetings to be submitted to at least two newspapers, one of which shall be the official newspaper, and the second a newspaper which has the greatest likelihood of informing the citizens of the Borough of Buena; and

WHEREAS, the Open Public Meetings Act of 1975 requires that notice of any meetings of the Borough of Buena not provided for in the annual schedule must be (1) posted in at least one public place reserved for public announcements; (2) mailed, telephoned, telegrammed or hand delivered to at least two newspapers designated by the public body; and (3) filed with the Clerk of the municipality.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE BOROUGH OF BUENA THAT:

The Clerk of the Borough of Buena is hereby authorized and directed to post and maintain posted on the official bulletin board located in the

Municipal Building, Borough of Buena, New Jersey, a copy of the attached schedule of regular meetings of the Council of the Borough of Buena for the year 2016 and to file a copy of said notice in the Office of the Borough Clerk.

2. Written notice of the date, time, place and agenda of any special meeting, rescheduling meeting, hearing or any other meeting of the Borough Council not provided for in the attached schedule as required by the Open Public Meeting Act of 1975, shall be posted by the Borough of Buena on the official bulletin board and filed; and maintained in the Office of the Borough Clerk.

3. The Atlantic County Record is hereby designated as the official newspaper of the Borough of Buena and said newspaper, together with the Press and Daily Journal are hereby designated to receive all notices of meetings required under the Open Meetings Act of 1975. The Clerk of the Borough of Buena is hereby authorized and directed to mail the attached schedule to the offices of the Atlantic County Record, the Press and the Daily Journal and to provide notices of all other meetings of the Borough of Buena to said newspapers in accordance with the provisions of the Open Meetings Act.

4. It is the opinion of this body that the Atlantic County Record, the Press and the Daily Journal have the greatest likelihood of informing the public within the jurisdictional area of this body of such meetings.

WHEREAS, the Borough of Buena has resolved to join the Atlantic County Municipal Joint Insurance Fund, a self insurance pooling fund, following a detailed analysis; and

WHEREAS, the by-laws of said fund require that each Municipality appoint a Risk Management Consultant to perform various professional services as detailed by the by-laws; and

WHEREAS, the by-laws indicate that the Risk Management Consultant shall be paid a minimum fee equal to six percent (6%) of the municipal assessment, which expenditure represents reasonable compensation for the services required of the Risk Management Consultant, and was included in the cost considered by the Council and;

WHEREAS, the judgmental nature of the Risk Management Consultant's duties renders competitive bidding impractical and;

WHEREAS, the Council has determined that it may enter into a professional services contract with a Risk Management Consultant pursuant to N.J.S.A. 40A:11-5.

NOW, THEREFORE, BE IT RESOLVED that the Council of the Borough of Buena does hereby appoint Michael D. Donato/Insurance Agencies Inc. as its Risk Management Consultant pursuant to the provisions of N.J.S.A. 40A:11-5.

BE IT FURTHER RESOLVED that the Mayor and the Clerk are hereby authorized and directed to execute the Consultant's Agreement annexed hereto and to cause of notice of this decision to be published in accordance with N.J.S.A. 40A:11-5(1) (a) (i).

WHEREAS, as a result of the failure of the Council on Affordable Housing (COAH) to enact Round 3 Rules upon which municipalities may base their application for fair share plans, the Supreme Court requires all municipalities within the jurisdiction of COAH to file a Declaratory judgment action and Motion for Immunity in the Superior Court; and

WHEREAS, the Law Firm of DeCotiis, Fitzpatrick & Cole, Teaneck, New Jersey, (Law Firm) have attorneys who specialize in this field of law and are capable of representing the Borough of Buena in this litigation and has agreed to charge an hourly rate of \$175.00 per hour with an amount not to exceed \$10,000.00 for a period of one year beginning June 23, 2015; and

WHEREAS, additional legal preparation has arisen as a result of circumstances unforeseen at the time of the execution of the original contract and the services are necessary as certified by the Borough Solicitor.

NOW THEREFORE BE IT RESOLVED by the Council of the Borough of Buena that the change order submitted by Law Firm of DeCotiis, Fitzpatrick & Cole, Teaneck, New Jersey increasing the original contract by \$6,703.07.

WHEREAS, N.J.A.C. 11:15-2.6 states that a Fund Commissioner who is an employee of the appointing member shall hold office at the pleasure of the member and can be removed by the member at any time without cause; and

WHEREAS, The Borough of Buena recommends the appointment of Joseph Santagata to serve as Fund Commissioner and the appointment of Valerie Santagata as Alternate Fund Commissioner in accordance with the FUND Bylaws.

**RESOLUTION 129-15**

**A RESOLUTION OF THE BOROUGH OF BUENA, COUNTY OF ATLANTIC, AUTHORIZING THE EXECUTION OF A SHARED SERVICE AGREEMENT WITH THE COUNTY OF GLOUCESTER, NJ FOR EMERGENCY DISPATCH SERVICES. m/Cuginis/Zappariello**

WHEREAS, Gloucester County is a body politic as defined as a local unit in N.J.S.A. 40A:65-1 et seq., with its main office located at Two South Broad Street, Woodbury NJ and operates dispatch facilities for emergency services including police, fire and EMS, which is capable of servicing areas including Buena Borough; and

WHEREAS, Buena Borough is in need of emergency dispatch for its police, fire and EMS, and is familiar with the County service having utilized the same in prior years; and

WHEREAS, N.J.S.A. 40-A:65-1 et seq., authorizes shared service agreements by and between municipalities and counties as a technique to reduce local expenses funded by property taxes; and

WHEREAS, the Council of the Borough of Buena finds that there are substantial cost savings to the Borough tax payers to share dispatch services rather than provide for its own and that the County can provide such services as good as those that have previously been provided for locally; and

WHEREAS, the proposed agreement is for a period of 10 years commencing December 1, 2015 and ending November 30, 2025 at a cost of \$134,088.00 for the first year and an annual increase thereafter based upon the Consumer Price Index-Urban Wage Earners (CPI-U) for the Philadelphia Region as published by the United States Department of Labor, with payments to be made quarterly as specified in the agreement

WHEREAS, the CMFO of Buena Borough has certified the availability of funds.

NOW, THEREFORE, BE IT RESOLVED by the Council of the Borough of Buena that the Mayor and Clerk are authorized to execute an agreement to provide emergency dispatch services for the Borough of Buena for police, fire, EMS and such other emergency dispatch provided by Gloucester County and required by the Borough.

BE IT FURTHER RESOLVED that the Shared Service Agreement shall be in the form substantially similar to the proposed agreement attached hereto, subject to modification by the Borough Solicitor, which shall be incorporated herein by reference.
