**MAYOR'S REPORT:** Mayor Baruffi reported that since taking office on January 2, 2024 he had met with the public safety committee concerning fire suppression issues, auditor Mike Garcia reviewing the budget, engineer Mark DeBlasio reviewing the status on infrastructures, and Road Supervisor Bill Nimohay on road and drainage projects along with County Commissioner Bertino on the county sections. Mayor Baruffi went on to update the meetings with residents' concerns such as Liberty Village US Mail delivery and 911, also giving appreciations to Chief Cirola, Congressman Jeff Van Drew and resident Nelson Albano for their efforts to resolve this concern. Mayor will continue to review other matters: landfill closure, developers interested in the 3.5 redevelop zone near the commerce Center, the Blackwater Pond, chickens and ducks in residential areas. Mayor itemized a meeting is scheduled with Council President Adam, Administrate Coraluzzo and CFO Holland reviewing the employees' health benefits and costs.

Mayor Baruffi then asked Mike Garcia to give a report update. Borough Auditor Mike Garcia gave an overview on Resolution No 38-24 for the additional temporary appropriations amounts that is requesting \$525,000. Garcia stated that every year at Reorganization meeting a temporary resolution is approved and had not included the fire protection and a capital plan. The actual Budget will be adopted in April. Garcia added that in review of the mayor commenting on the landfill closure, there is an account for landfill closure costs of \$30,000.00 and is used specifically for that.

**WHEREAS**, the Borough of Buena expends a great deal of money in the physical and medical evaluations, training, education and uniforms for new employees to assure the Borough has the best trained and physically fit employees possible, which training and education makes the employees more valuable to the Borough and other agencies; and

**WHEREAS** many times new hires leave the Borough employ after receiving costly training and education as well as physical and medical evaluations and obtain employment with other agencies both public and private utilizing the training and education garnered at the taxpayers' expense; and

**WHEREAS**, while the Borough Council finds it understandable for new employees to take positions elsewhere within the first three years of employment in what the employee determines to be in his/her best interest, it is unfair to allow the employee to do so without reimbursing the Borough for costs and expenses incurred to better train and educate said employee which is done so the employee can provide the Borough with an exceptional employment future; and

**WHEREAS**, it is the intent of the Borough Council to establish a policy setting forth those circumstances that shall require the applicant for employment to reimburse the Borough for such expenses hereinbefore described.

**NOW, THEREFORE, BE IT ORDAINED** by the Borough Council of the Borough of Buena that all applicants for employment positions with the Borough shall execute an Applicant Reimbursement Agreement which states as follows:

A.For all municipal employees resigning their position less than two years after appointment or hire and are appointed or hired to a similar position in either the public or private employment which requires said employee to utilize the skills and/or certifications obtained through the Borough of Buena shall reimburse and is liable to the Borough for the total certified costs incurred by the Borough in the examination, hiring and training of the person as well as costs for uniforms and other equipment which cannot be used by other Borough employees or readily sold to recoup the cost.

B.For all municipal employees resigning their position less than three years but more than two years after appointment or hire and are appointed or hired to a similar position in either the public or private employment which requires said employee to utilize the skills and/or certifications obtained through the Borough of Buena shall reimburse and is liable to the Borough for fifty (50%) percent of the total certified costs incurred by the Borough in the examination, hiring and training of the person as well as costs for uniforms and other equipment which cannot be used by other Borough employees or readily sold to recoup the cost.

C.Should it become necessary for the Borough, their agents, assigns and/or employees to incur costs and expenses to retain the services of an attorney to enforce the Agreement, the Applicant agrees to pay those reasonable costs and attorney's fees expended to enforce the terms of the Agreement.

**WHEREAS**, the Municipal Code of the Borough of Buena § 82-1 created the position of Occupancy Inspector to be appointed by the Council of the Borough of Buena and to hold office for a term of one year;

**WHEREAS**, the duties of the Occupancy Inspector included enforcing the property maintenance code and of issuing occupancy permits for all dwellings in the Borough of Buena, including but not limited to dwelling units, rooming units, dormitory units, rooming houses, single- and two-family dwellings and all other dwellings as defined in the property maintenance code which are subject to the jurisdiction of the Occupancy Inspector;

**WHEREAS**, Civil Service Classifications do not include a position known as Occupancy Inspector, instead the duties of the Occupancy Inspector fall under the Civil Service Title of Housing Inspector, which include specific training, experience and licensing:

**WHEREAS**, consistent with the Civil Service Classification, pursuant to Ordinance No. 743-23 the duties of the Occupancy Director were transferred to the Borough’s Housing Inspector a Classified position which has not yet been created by Ordinance.

**NOW THEREFORE, BE IT ORDAINED**, the Council of the Borough of Buena, New Jersey, the governing body of the Borough of Buena that the Municipal Code § 82-1 be, and is hereby replaced with the following:

**§ 82-1 Creation of position of Housing Inspector, and Housing Inspector Trainee:**

There is hereby created within the Borough of Buena one or more positions known as "Housing Inspector," to replace the position of Occupancy Inspector. The Housing Inspector(s) shall be appointed by the Council of the Borough of Buena in accordance with the rules and regulations of the New Jersey Civil Service Commission. Such Housing Inspector(s) shall have the duty of enforcing the property maintenance code which was adopted by the Council of the Borough of Buena pursuant to **Ordinance No. 446**, as amended by **Ordinance No. 743-23**, and of issuing occupancy permits for all dwellings in the Borough of Buena, including but not limited to dwelling units, rooming units, dormitory units, rooming houses, single and two-family dwellings and all other dwellings as defined in the property maintenance code which are subject to the jurisdiction

of the Housing Inspector(s). The salary of the Housing Inspector(s) shall be as provided in the Salary Ordinance of the Borough of Buena.

There is hereby created within the Borough of Buena the position known as "Housing Inspector Trainee." The Housing Inspector Trainee shall be appointed by the Council of the Borough of Buena in accordance with the rules and regulations of the New Jersey Civil Service Commission. The Housing Inspector Trainee shall work under and take direction from the Housing Inspector(s). The Housing Inspector Trainee will receive training and experience by assisting the Housing Inspector(s) with the performance of his or her duties, and otherwise have the duties set forth in the rules and regulations of the Civil Service Commission. The salary of the Housing Inspector Trainee shall be as provided in the Salary Ordinance of the Borough of Buena.

**WHEREAS**, in November 2020, a State Referendum was voted upon by the residents of the State of New Jersey to ascertain public opinion on adult use cannabis which reflected that 67% of the voting population is in favor of the legalization of adult use cannabis in the State and as a result, the State Legislation adopted the New Jersey Cannabis Regulatory Enforcement Assistance and Marketplace Act (CREAMM) N.J.S.A. 24:6I-31, et seq; which establishes the authority by which municipalities may regulate the sale and use of adult use cannabis; and

**WHEREAS**, N.J.S.A. 24:6I-45 authorizes municipalities to adopt legislation governing the number and types of cannabis businesses as established under CREAMM and further required municipalities not wishing to accept cannabis businesses to adopt such legislation on or before August 2021 or such municipalities shall be required to allow all types of licenses; and

**WHEREAS**, Buena Borough did not adopt such legislation within the time set forth in N.J.S.A. 24:6I-45 and therefore all classes of cannabis businesses are permitted within the Borough, however the Borough Council wishes to establish the number of each type of license, the manner of operation, location thereof, among other permitted restrictions.

**NOW THEREFORE BE IT RESOLVED** by the Council of the Borough of Buena that the Acting Clerk is hereby authorized to advertise for Proposals to be received for the issuance of one Cannabis Class 1 Cultivation License in the Borough of Buena.
