CuvIELLO, PP, LLC., specializes in Housing Element and Fair Share Plans as required in accordance with the Affordable Housing Laws and the process in which to prepare and completed a Fair Share Housing Plan and has submitted a proposal indicating she will provide the professional service on a time-charge basis at a rate of \$150.00 per hour and in an amount not to exceed \$20,000.00; and

WHEREAS, Tiffany A. CuvIELLO, PP, LLC. has or shall submit a Business Entity Disclosure Certification for Non-Fair and Open Contract which certifies that the firm has not made any reportable contributions to a political or candidate committee in the Borough of Buena in the previous one year and that the contract will prohibit Tiffany A. CuvIELLO, PP, LLC, from making any reportable contributions through the term of the contract or its extension to a political or candidate committee in the Borough of Buena; and

WHEREAS, the availability of funds for said Professional Services Contract to be awarded have been certified by the Borough Chief financial Officer; and

WHEREAS, the Local Public Contract Law (N.J.S.A. 40 A: 11 – 1, et seq.) requires that the Resolution authorizing the award of contract for Professional Services without competitive bidding and the contract itself must be available for public inspection.
