There is continuous cleaning of the Boro Buildings.

Quotes are being received for roof repairs for council chambers, and lights in the outside areas of Borough Buildings and fields.

Louise Basile building needed a sheet rock wall replaced.

Dog waste stations are available along the walking path.

No hunting signs will be placed at Black Water Pond Park.

AED (Automated External Defibrillator) been obtained by EMS Chief for the Borough Hall, and is working on acquiring one for the Historical Society Building. EMS Chief Ciraolo stated training will be available for the Borough employees.

The Senior Center needs a new Bingo Machine, monies have been raised however additional donations are being accepted for the final costs.

RECREATION/SPECIAL EVENTS: (CHAIRWOMAN, MARINA BARSUGLIA)

Councilwoman Barsuglia reported that the Concerts in the Park will begin July 20th. Picking will begin at the community garden; additional plants continue to be donated. Blackwater pond cleaning continues, deer stands and a duck blind have been found.
