WHEREAS, the Borough of Buena presently owns the Buena Senior Hall, located at Central Avenue, in the City of Minotola and State of New Jersey, recorded as Block 126, Lot 27, in the Borough of Buena Tax map; and

WHEREAS, said Buena Senior Hall currently houses programs for senior adults residing in the Borough of Buena; and

WHEREAS, the County of Atlantic and the Atlantic County Nutrition Project is desirous of providing meals to senior adults residing in the Borough of Buena; and

WHEREAS, the County of Atlantic may also provide programs specified under the "Older Americans Act"; and

WHEREAS, the County of Atlantic has agreed to pay one dollar per year for a term of three (3) years beginning January 1, 2025 and ending on December 31, 2027.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE BOROUGH OF BUENA that the Mayor and Acting Clerk are hereby authorized to enter into a Nutrition Site lease agreement with the County of Atlantic for the purpose of serving meals to senior adults residing in the Borough of Buena under a federally funded program which operates through the Atlantic County Nutrition Project and for the purpose of permitting the County of Atlantic to provide other programs for senior adults specified under the "Older Americans Act", which lease agreement shall provide for a rent of one dollar per year for a term of three years retroactive to January 1, 2025 and ending on December 31, 2027 and permitting the County of Atlantic to renew the lease agreement on a three year basis.

BE IT FURTHER RESOLVED that the Acting Clerk be and she is hereby authorized to forward an executed copy of said Nutrition Site Lease agreement, together with a certified copy of this Resolution to the above-named County of Atlantic.

PLANNING/ZONING/INSPECTIONS COUNCILMAN RICHARD GIOVINAZZI:

- A trial date of January 10, 2025 is set for the following properties:

- 110 E Arbor Ave. had a trial date of Friday, November 22, 2024 and the tenant was found guilty. The Judge issued a fine of \$12,600.00 and ordered the property to be cleaned in a timely manner.

PUBLIC SAFETY/STREET LIGHTS

COUNCILMAN DOUGLAS ADAMS:

- Franklin Township Police department responded to 993 calls for service for Buena Borough for the month of October.
- Officer Omar Alam was nominated Officer of the Month. He is a Class II Officer who will be promoted to full time status in December.
- Chief DeCesari reported on the fire that occurred at the Budget Lodge on November 25, 2024, noting smoke and flames coming from two rooms on the corner of the building. Upon arrival, the fire department was able to control the fire. The fire is believed to be intentional and a suspect was taken into custody. Newfield Terrace Community Center and Franklin Township Police Department will host Holiday with a Hero on December 7, 2024 where Officers will take 13 community

children shopping through donations from various local businesses.

- A total of 95 EMS calls were reported for the month of October. 47 of those calls were for Buena Borough and 48 for Buena Vista Township. The Borough is still assisting Buena Vista Township in rescue squad calls. They are currently responding to two out of every three calls throughout the hiring process. In an email conversation with Buena Vista Township's administrator, it was noted that they expect to be up and running by December 1, 2024.
- Buena Borough Fire Department responded to 137 calls in October to date with 20 for the month of November.
- Atlantic City Electric is researching the reimbursement of street lights that have been out in the Borough for over three years.
- Reported that street lights are in the process of being repaired and requested residents to continue to report any outages.

RECREATION

COUNCILWOMAN MARINA BARSUGLIA:

- The annual Christmas Event is December 7, 2024. The parade line-up will begin at the Cleary School at 5:30 p.m. and travel down Central Ave. and end at Melini Park for the tree lighting with other holiday activities. Road Supervisor Nimohay donated the trophies to be awarded to the best float in the parade.
- The tennis courts are still being repaved and trees are being removed from the stream at Blackwater Pond. In December, the beaver issue will be addressed with the Fish and Game Commission.

WHEREAS, N.J.A.C. 11:15-2.6 states that a Fund Commissioner who is an employee of the appointing member shall hold office at the pleasure of the member and can be removed by the member at any time without cause; and

WHEREAS, The Borough of Buena recommends the appointment of William Nimohay to serve as Fund Commissioner and the appointment of Valerie Santagata-Jones as Alternate Fund Commissioner in accordance with the FUND Bylaws.
