WHEREAS, on July 29, 2021, the Council of the Borough of Buena adopted Ordinance 701 dissolving Buena Borough Fire District No. 1 and expanding Buena Borough Fire District No. 2 wherein, at Section 3, ordained to transfer all real and personal property owned or titled in the name of Borough of Buena Fire District No. 1 unto Buena Borough Fire District No. 2, including the land and improvements previously utilized for Landisville Fire Company (Building); and

WHEREAS, Borough Council has reconsidered the transfer of the Building to Fire District No 2 as it may be best served as a station for the Emergency Medical Services of the Borough which presently occupy a portion of the Commerce Center facility; and

WHEREAS, by moving the Emergency Medical Services out of the Commerce Center to the Building, the Borough would allow the Commerce Center location to be rented to a business, thereby providing for a tax ratable, job creation and an incentive to a future Master Tenant to occupy the Commerce Center and the use of the Building will not remove a tax ratable from the tax roles as the Building was exempt from taxation; and

WHEREAS, Borough Council has also received a petition duly signed by at least 5% of the registered voters for the Council to consider the creation and designation of a fire district in accordance with N.J.S.A. 40A:14-70, which, if favorably considered, may cause the Building and other assets to revert back to the newly created fire district and it would not be in the best interest of the Borough to allow the transfer of assets pursuant to Ordinance 701 only to later consider the creation of a fire district if it is considered in the best interest of the residents; and

WHEREAS, the Borough Council finds it to be in the best interest of the Borough to stay the transfer of assets to Fire District No. 2 until further consideration of Borough Council.

NOW, THEREFORE, BE IT ORDAINED by the Council of the Borough of Buena that Ordinance 701 be and is hereby amended to stay the operation of Section 3 of Ordinance 701 until further consideration of Borough Council.

BE IT FURTHER ORDAINED that any Ordinance or portion thereof that is inconsistent with the terms of this Ordinance shall be repealed to the extent of such inconsistency.

WHEREAS, N.J.S.A. 19:44A-20.4 requires municipalities to adopt fair and open procedures for awarding professional service agreements which are otherwise exempt from public bidding pursuant to N.J.S.A. 40A:11-5; and

WHEREAS, the Borough Council of the Borough of Buena believes it is in the best interest of the Borough of Buena to select professionals primarily on the basis of their qualifications, including qualifications uniquely suited to the needs of the Borough of Buena; and

WHEREAS, to receive statements of qualifications in a manner that fosters a fair and open process, it is necessary and advisable to establish advance general criteria and specific minimum requirements; and

WHEREAS, the Borough Council of the Borough of Buena has determined that a fair and open process requires public advertisement of professional services required in a manner and with sufficient time to provide notice in advance of the contemplation of retaining the services of a professional and the criteria to be considered in determining the best professional for the position; and

WHEREAS, a fair and open process requires that all responses be publicly opened and announced and thereafter that all appointments be made at a public meeting of the Borough Council and then published in accordance with N.J.S.A. 40A:11-5.

NOW, THEREFORE, BE IT RESOLVED by the Borough Council of the Borough of Buena as follows:

- 1) All appointments for Professional Services contained on Schedule A attached to and made a part hereof shall be subject to a fair and open process as set forth below.
- 2) The Borough Clerk shall cause all legal notices to be published on the website for the Borough of Buena stating that a full listing of all professional service appointments subject to a fair and open process together with the criteria established for the consideration of qualification, will be posted at Borough Hall beginning no later than November 18, 2022.
- 3) The criteria for each position contained on Schedule A follows immediately subsequent to the Listing on Schedule A. The criteria shall be disclosed, together with the posting of the listed positions at Borough Hall.
- 4) The website posting shall inform potential applicants that all submissions must be made to the Borough Clerk and received no later than 12:00 noon, December 8, 2022.

- 6) The appropriate department heads and the representatives from the appropriate boards shall thereafter review all submissions and report to the Mayor with recommendations.
