Completenss and Review Application:

Cheli Application:

Erin Cheli sworn in. Plans to open a retail sporting goods store 296 Wheat Road Block:173;Lot 42.02 in a pre-existing commercial building. Area is zoned residential but original plan of the borough has a commercial corridor to accommodate commercial property on Wheat Road. Plan for sporting goods store must show negative criteria and no detriment to public.

Applicant requesting a use variance and site plan waiver. One sign to be placed on top of building measuring 4X8. Operating hours not decided but store will be opened 7 days a week. As long as no structural changes are made to the property, Engineer Edward J. Walberg will accept modified site plan to address handicap parking and ramp, lighting, trash, signage, and any fencing. Four mounted lights one on each side of building was suggested. Type of paving for handicap parking must be addressed.

Applicant must make application to Atlantic County Planning Board because Wheat Road is a County Road. Applicant must satisfy county requirements. If county accepts modified site plan, same plan must be resubmitted to the Buena Borough Land Use Board for approval and resend notices to public. Applicant must apply for all necessary permits to satisfy Buena Borough and any outside agency. Modified plan may be hand drawn.

Public Portion:

Dennis Cheli (Senior): Sworn in. Questioned if board could require changes to property to accommodate business even if previous occupants did not have to satisfy the same requirements. Board answered yes.

Joseph Fabrizio: Sworn in. Lives next door to property. In favor of business. Stated previous occupants did do a site plan waiver and it was accepted by County and Borough. Suggested temporary handicap ramps and stated 1 handicap parking space does not require drainage site plan.
